The PCC Group generates revenue from operations in 3 major divisions – chemicals, energy, and logistics.

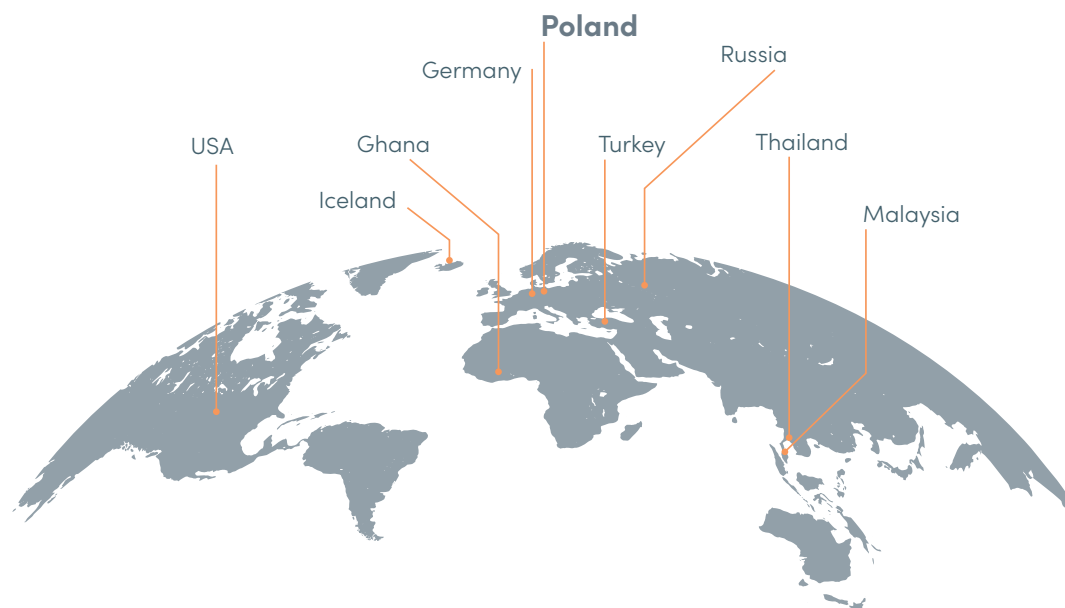


The revenue of the PCC Group increased from EUR 59.4 million in 1994 to EUR 716.2 million in 2020.
