

1. CHEMICAL COMPOSITION <5% chlorine-based bleaching agents, <5% nonionic surfactants, anionic surfactants, <5% phosphonate, 5% fragrance composition.

3. APPLICATION

Liquid for hygienic hand disinfection, various surfaces, and devices. It has bactericidal, fungicidal, and virucidal properties. Contains glycerin. Ready-to-use. To disinfect hands: Rub 2 x 3 ml of the liquid into dry hands for 30 seconds. Keep hands moist with the liquid throughout the specified exposure time. Allow hands to dry. Do not rub hands. Do not rinse with water. To achieve the desired effect, wash hands before using the product. Surface disinfection: Apply the product to clean surfaces. Leave on the surface to dry. The product is effective within 5 minutes. Do not rinse the surface. Biocidal product marketing authorization number: 8047/20.
