Procedura:

1. In recipienti separati unire gli ingredienti della fase A e B. Riscaldare fino a 75-80°C.
 2. Aggiungere la fase A alla fase B durante la miscelazione. Omogeneizzare 60-90 sec. In un recipiente separato unire gli ingredienti della fase C. Mescolare fino a ottenere un composto uniforme.
 3. Raffreddare il lotto fino a 50°C durante la miscelazione. Aggiungere gli ingredienti della fase C durante la miscelazione. Omogeneizzare a 2500-3500 RPM, 90 sec.
4. Raffreddare il lotto fino a 30°C durante la miscelazione.
 5. Aggiungere le fasi D ed F durante la miscelazione. Omogeneizzare a 2500-3500 RPM, 90 sec
