Prosedur:

1. Dalam bekas berasingan gabungkan bahan-bahan dari fasa A, A1.
2. Sediakan bahan lain – fasa B dan C.
3. Panaskan fasa A dan B kepada 75-80°C.
4. Masukkan perlahan-lahan fasa A1 ke fasa A sambil mengadun. Kekalkan suhu (fasa A/A1) pada 75-80°C.
5. Masukkan ROKanol S20 dengan perlahan-lahan (tambah bahagian kecil semasa mengadun. Tunggu sehingga seragam) untuk adunan diiring fasa A/A1. Kekalkan suhu 75-80 ° C sehingga larut.
6. Masukkan fasa C semasa mengadun.
7. Sejukkan batch hingga 70°C.
