Postup:

1. V oddelených nádobách zmiešajte zložky z fázy A a B.
 2. Pridajte fázu B do fázy A počas miešania. Homogenizovať 60-90 sekúnd. V oddelenej nádobe zmiešajte zložky z fázy C. Miešajte, kým nie je homogénna.
 3. Počas miešania pridajte fázu C. Homogenizujte pri 2500-3500 ot./min., 45 sekúnd.
4. Počas miešania pridajte fázu D. Homogenizujte pri 2500-3000 ot./min., 45 sekúnd.
 5. Počas miešania pridajte zložky fázy E - F. Homogenizujte pri 2500-3500 ot./min., 90 sekúnd.
