Procedimento:

1. Em um copo misture Esclerócio e Goma Xantana com Glicerina.
 2. Em outro béquer, misture Aqua com Substância Ativa (fase A). Misture e aqueça até 60 – 70°C. Adicione Sclerotium e Xanthan Gum com Glicerina.
 3. No recipiente principal misture a fase B e aqueça até 60 – 70 °C.
 4. Adicione a fase A à fase B e homogeneíze com 2500 – 3500RPM, 90 – 120seg. Resfrie o lote até 40°C enquanto mistura.
5. Misture Poliacrilato de Sódio com EXOsoft AB25. Adicione a fase de repouso C e misture.
 6. Adicione a fase C ao béquer principal, misture e homogeneíze com 2500 – 3500 RPM, 90 – 120 seg.
