절차:

1. A 단계의 재료를 섞습니다. A 단계의 재료를 따뜻한 물 (55-60°C)에 넣습니다. 균일한 용액이 얻어질 때까지 혼합합니다. 배치를 50°C 이상으로 식힙니다.
2. 상 B의 재료를 첨가합니다. 균일해질 때까지 혼합합니다.
3. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate를 추가합니다. 균일해질 때까지 섞는다. 배치를 30°C 이상으로 식힙니다.
4. 혼합하는 동안 Cocamidopropyl Betaine 첨가하십시오. 균일해질 때까지 섞는다.
5. 필요한 경우 Lactic Acid로 pH를 4.8 - 5.3으로 조정하십시오.
