Prosedur:

1. Satukan bahan-bahan dari fasa A. Tambah bahan-bahan dari fasa A ke air (30-35°C). Campurkan sehingga larutan homogen diperolehi. Sejukkan kumpulan ke sekurang-kurangnya 30°C.
2. Masukkan bahan dari fasa B. Gaul hingga sekata.
3. Satukan bahan dari fasa C dalam bekas yang berasingan. Tambah Parfum ke Polysorbate 20 - gaul sehingga seragam.
4. Masukkan fasa C ke dalam bekas utama semasa mengadun. Gaul sehingga seragam.
5. Masukkan Cocoamidopropyl Betaine semasa mengadun. Gaul sehingga seragam.
6. Jika perlu, laraskan pH oleh Asid Laktik kepada 4.8 - 5.2.
