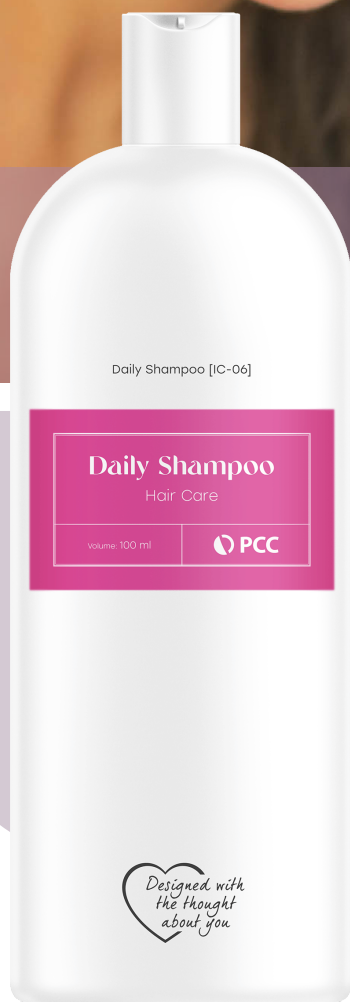

Postup:

1. Smíchejte konzervační prostředek a betain s vodou, dokud ne získáte homogenní roztok.

2. Přidejte glycerin a promíchejte.

3. Poté přidejte SULFOROKAnol L227/1 nebo SULFOROKAnol L325 nebo SULFOROKAnol IT330 a promíchejte.

4. Přidejte ROKAtend LS a promíchejte.
5. Poté přidejte ROKAmina K30, promíchejte.

6. Přidejte ovocný extrakt Cucumis Sativus (Okurka) a promíchejte.

7. Přidejte roztok kyseliny citrónové, aby bylo dosaženo pH ve hmotě kolem 4,5–5,5.
