## Postup:

1. SULFOROKAnol L227/1 miešajte s vodou, kým sa nerozpustí.
2. Pridajte ROKAcet KO400G/ ROKAnol L7/ ROKAnol MT7E/ ROKAmid MRZ11 a premiešajte.
3. Potom pridajte Magnesium Laureth Sulfate a premiešajte.
4. Pridajte EXOsoft PO30 a premiešajte.
5. Potom pridajte styren/akrylový kopolymér a premiešajte.
6. Pridajte glycerín, premiešajte.
7. Pridajte GLDA-Na4 a premiešajte.
8. Nakoniec pridajte kyselinu citrónovú, kým sa pH hmoty nedosiahne na približne 9.
