절차:

2. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate를 추가합니다. 균일해질 때까지 섞는다. 배치를 30°C 이상으로 식힙니다.
3. 혼합하는 동안 Cocamidopropyl Betaine 과 Parfum 을 첨가하십시오. 균일해질 때까지 섞는다.

4. 혼합하는 동안 염화나트륨을 첨가합니다(소량 첨가 및 용해).

5. 필요한 경우 Lactic Acid로 pH를 4.8 - 5.3으로 조정하십시오.
