## Procedure:

1. Meng de ingrediënten van fase A en B in aparte kommen. Verwarm tot 60-70 °C. Voeg fase A al roerend toe aan fase B. Homogeniseer met 2500-3500 tpm, 90-120 sec.
2. Laat het mengsel afkoelen tot 30°C en blijf roeren.
3. Voeg fase C en D toe tijdens het mixen. Homogeniseer met 1500-2000 tpm, 90-120 sec.
4. Controleer de pH-waarde en voeg indien nodig meer natriumhydroxide toe tot 5,0 – 6,0.
