3. Tillsätt PEG-120 Methyl Glucose Dioleate och Coco-Glucosid, Glyceryl Oleate under blandning. Blanda tills det är enhetligt. Kyl satsen till minst 30°C.
4. Tillsätt långsamt Coco Betaine under blandningen. Blanda tills det är enhetligt.
