3. Počas miešania pridajte PEG-120 metylglukózodioleát. Miešajte, kým nebude jednotná. Násada sa ochladí aspoň na 30 °C.
4. Počas miešania pridajte Cocoamidopropyl Betaine. Miešajte, kým nebude jednotná.
