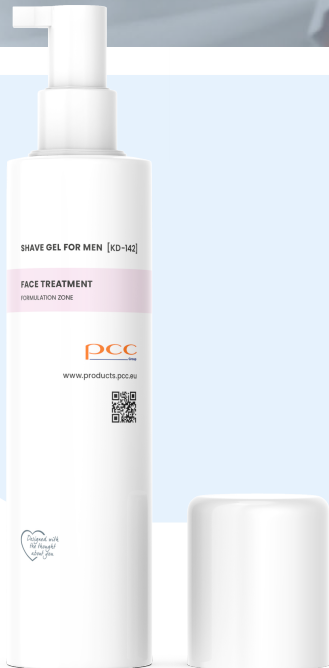

- Karıştırırken faz C bileşenlerini ekleyin. 2000-3000 RPM, 120-180 sn ile homojenize edin.
