Procedur:

1. Blanda ingredienserna från fas A och B i separata kärl. Värm upp till 60–70 °C. Tillsätt fas A till fas B under omrörning. Homogenisera med 2500–3500 varv/min, 90–120 sekunder.
2. Kyl ner satsen till 30°C under omrörning.
3. Tillsätt fas C och D under omrörning. Homogenisera med 1500–2000 varv/min, 90–120 sekunder.
4. Kontrollera pH-värdet, tillsätt vid behov mer natriumhydroxid till 5,0–6,0.
