## Procedur:

1. Kombinera ingredienser från fas A och B i separata kärl. Värm upp till 75-80°C. Tillsätt fas B till fas A under blandning.
2. Homogenisera med 1500-2000 RPM, 90-120 sek.
3. Kyl ner satsen till 70°C under blandning. Tillsätt C ingredienser under omrörning. Homogenisera med 1500-2000 RPM, 90-120 sek.
4. Kyl ner satsen till 30°C under blandning. Tillsätt övriga ingredienser under omrörning. Homogenisera med 1500-2000 RPM, 90-120 sek.
