- Sodyum Lauroyl Sarcosinate ekleyin. Üniforma kadar karıştırın. Partiyi en az 30°C'ye soğutun.
- Gerekirse Sitrik Asit ile pH'ı 5,0 – 7,0'a ayarlayın.
