Procedure:

1. Combineer ingrediënten uit fase A in een hoofdvat. Voeg Xanthaangom toe aan Glycerine - meng tot een homogene oplossing is verkregen. Voeg warm water toe (50-55°C). Meng tot een homogene oplossing is verkregen. Homogeniseer gedurende 2-3 minuten.
 2. Voeg de fase B-componenten toe. Meng tot uniform. Koel de batch af tot 35°C.
3. Wanneer de batchtemperatuur 35°C is, Cocamidopropyl Betaine toevoegen tijdens het mengen. Meng tot uniform.
 4. Controleer het pH-bereik - voeg indien nodig melkzuur toe. Meng goed na aanpassing.
