Procedur:

- Häll det avjoniserade vattnet (25-30°C) i huvudkärlet och tillsätt Acrylates/C10-30 Alkyl Acrylate Crosspolymer. Börja blanda när polymeren är helt blöt. Blanda tills den homogena lösningen erhålls. Homogenisera i 1-2 minuter.
 - Kombinera ingredienser från fas B i ett separat kärl. Värm upp till 40-45°C med försiktig omrörning. Blanda tills homogen lösning erhålls.
- Tillsätt långsamt fas B till fas A under blandning. Blanda tills det är enhetligt.
 - Tillsätt konserveringsmedel, Cocamidopropyl Betaine och Parfym under blandning. Blanda tills det är enhetligt.
