Procedura:

1. In recipienti separati unire gli ingredienti della fase A e B.
 2. Aggiungere la fase B alla fase A mescolando. Omogeneizzare 60-90 sec. In un recipiente separato unire gli ingredienti della fase C. Mescolare fino ad ottenere un composto omogeneo.
 3. Aggiungere la fase C mescolando. Omogeneizzare a 2500-3500 giri/min, 45 sec.
4. Aggiungere la fase D mescolando. Omogeneizzare a 2500-3000 giri/min, 45 sec.
 5. Aggiungere gli ingredienti della fase E - F continuando a mescolare. Omogeneizzare con 2500-3500 RPM, 90 sec.
