Postup:

1. V oddelených nádobách zmiešajte zložky z fázy A a B.
 2. Pripravte si ostatné ingrediencie – fáza A1, C a D.
 3. Zahrejte fázy A a B na 75-80 °C.
 4. Pridajte ROKAnol LK3 do fázy A, udržiavajte A/A1 pri 75-80°C.
 5. Počas miešania pridajte ROKAnol® T25 Flakes (fáza B) do fázy A/A1. Udržujte teplotu 75-80 °C až do rozpustenia.
6. Násada sa ochladí na 50 °C. Počas miešania pridajte zložky fázy C a D.
 7. Násada sa ochladí na 25 °C.
