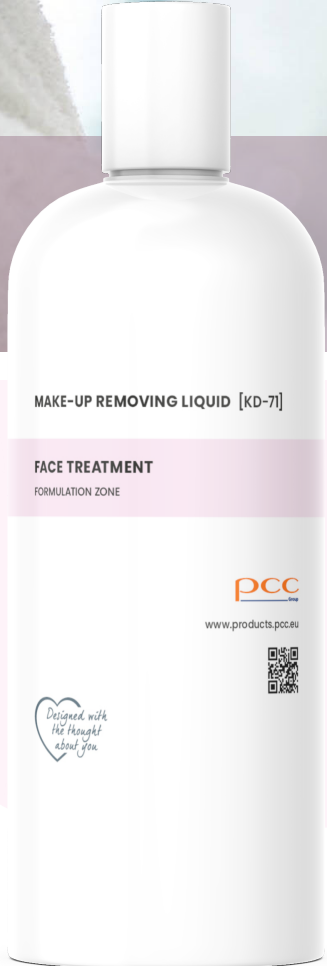

절차:

1. 주 용기에 상 A의 재료를 넣고 65-70°C까지 가열합니다.
2. Xanthan Gum을 글리세린에 첨가하고 균일해질 때까지 혼합합니다. 혼합하면서 B상을 A상에 추가합니다. 균일해질 때까지 섞는다.
3. 배치를 50°C 이상으로 식힙니다.
4. 별도의 용기에 상 D의 성분을 혼합하고 균일해질 때까지 혼합합니다.
5. 혼합하면서 상 C, D 및 E의 성분을 상 A에 첨가합니다. 균일해질 때까지 섞는다.
