Procédure:

1. Dans un récipient principal, combiner les ingrédients de la phase A et chauffer jusqu'à 65-70°C.
 2. Ajouter la gomme de xanthane à la glycérine - mélanger jusqu'à uniformité. Ajouter la phase B à la phase A tout en mélangeant. Mélanger jusqu'à homogénéité.
3. Refroidir le lot à au moins 50°C.
 4. Combiner les ingrédients de la phase D dans un récipient séparé et mélanger jusqu'à homogénéité.
 5. Ajouter les ingrédients des phases C, D et E à la phase A tout en mélangeant. Mélanger jusqu'à homogénéité.
