## Procedimiento:

1. En un recipiente principal combine los ingredientes de la fase A. Mezcle hasta que quede uniforme.
2. Agregue ROSULfan A mientras se mezcla. Mezclar hasta que quede uniforme.
3. Agregue lentamente ROKamina K30 y Parfum mientras mezcla. Mezclar hasta que quede uniforme.
4. Agregue EXOpearl SF mientras mezcla. Mezclar hasta que quede uniforme.
5. Agregue lentamente cloruro de sodio. Mezclar hasta que quede uniforme. NOTA: Agregue cloruro de sodio en pequeñas porciones. Controle la viscosidad después de cada porción.
