2. Partiyi en az 35°C#39;ye kadar soğutun.
3. Karıştırma sırasında B fazını ekleyin. Homojen bir çözelti elde edilene kadar karıştırın.

4. Karıştırmaya faz CD malzemelerini ekleyin ve homojen hale gelene kadar karıştırın.
5. pH#39;ı Laktik Asit ile 5,0-5,5#39;e ayarlayın.
