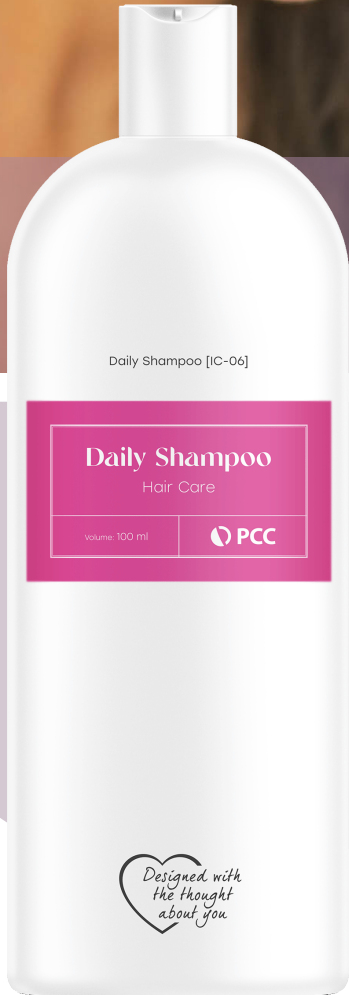

2. Gliserini ekleyip karıştırın.
3. Daha sonra SULFOROKAnol L227/1 veya SULFOROKAnol L325 veya SULFOROKAnol IT330 ilave edilip karıştırılır.
4. ROKAtend LS'yi ekleyip karıştırın.
5. Daha sonra ROKAmina K30'u ekleyip karıştırın.
6. Cucumis Sativus (Salatalık) Meyve Özütü'nü ekleyip karıştırın.
7. Elde edilen kütlenin pH'si 4,5–5,5 civarına gelinceye kadar sitrik asit çözeltisi ilave edilir.
