## Procedure:

1. Combineer in aparte vaten de ingrediënten van fase A en B. Homogeniseer fase A: 1500-2000 RPM 90-120 s.
2. Verwarm fase A en B tot 75-80°C.
3. Voeg tijdens het mengen fase B toe aan A. Homogeniseren: 1500-2000 RPM 90-120 s.
4. Koel de batch af tot 30°C terwijl u mengt.
5. Voeg tijdens het mixen fase C-ingrediënt toe. Homogeniseren: 1500-2000 RPM 90-120 s.
