Postup:

1. Zmiešajte ingrediencie z fázy A. Pridajte ingrediencie z fázy A do horúcej vody (75-80°C). Miešajte, kým sa nedosiahne homogénny roztok. Násada sa ochladí aspoň na 50 °C.
2. Pridajte lauroylsarkozinát sodný. Miešajte, kým nebude jednotná. Násada sa ochladí aspoň na 30 °C.
3. V prípade potreby upravte pH kyselinou citrónovou na 5,0 - 7,0.
