Процедура:

1. Змішайте флуоресцентний освітлювач з водою до повного розчинення.
2. Додати гліцерин і GLDA-Na4, перемішати.
3. Додайте ROKAcet KO400G/ ROKAnol L7/ ROKAmid MRZ11 і перемішайте.
4. Потім додати SULFOROKAnol L290/1M/ SULFOROKAnol L390/1M, перемішати.
5. Додайте гідроксид натрію до досягнення рН маси приблизно 8,0-8,5.
6. Нарешті, додайте ферменти та перемішайте.
