Postup:

1. V hlavnej nádobe zmiešajte ingrediencie z fázy A a zohrejte na 65–70°C.

2. Pridajte xantánovú gumu do glycerínu – miešajte, kým nebude jednotná. Pridajte fázu B do fázy A počas miešania. Miešajte, kým nebude jednotná.
3. Násada sa ochladí aspoň na 50 °C.

4. Zmiešajte zložky z fázy D v samostatnej nádobe a miešajte, kým nie sú jednotné.

5. Počas miešania pridajte prísady z fázy C, D a E do fázy A. Miešajte, kým nebude jednotná.
