- Karıştırırken PEG-120 Metil Glikoz Dioleat ekleyin. Üniforma kadar karıştırın. Partiyi en az 30°C'ye soğutun.
- Karıştırırken Cocoamidopropyl Betaine ekleyin. Üniforma kadar karıştırın.
