1. Mix EXOsoft PC35 with water until dissolved.
 2. Add Citric Acid to pH of about 7.5
 3. Add SULFOROKAnol L227/1 and mix.
 4. Then add ROKAnol L4 and mix
 5. Add EXOtrope SCS and mix.
 6. Add 2-Butoxyethanol and ethanol and mix.
7. Add Nonionic carnauba emulsion and mix.
 8. Finally, add Methylisothiazolinone, Metylochloroizotiazolinon and parfum and mix until.
