Procédure:

 - Ajouter les ingrédients de la phase B pendant le mélange. Mélanger jusqu’à homogénéité.
- Ajouter PEG-120 Methyl Glucose Dioleate tout en mélangeant. Mélanger jusqu’à homogénéité. Refroidir le lot à au moins 30°C.
 - Ajouter Cocoamidopropyl Bétaïne tout en mélangeant. Mélanger jusqu’à homogénéité.
