Procedimiento:

1. En un recipiente aparte combine los ingredientes de la fase A, A1.
 2. Prepare otros ingredientes: fases B y C.
 3. Calentar la fase A y B a 75-80°C.
 4. Agregue lentamente la fase A1 a la fase A mientras mezcla. Mantener la temperatura (fase A/A1) a 75-80°C.
 5. Agregue muy lentamente ROKanol S20 (agregue una pequeña porción mientras mezcla. Espere hasta que esté uniforme) a la fase A/A1 durante la mezcla. Mantener la temperatura de 75-80°C hasta su disolución.
6. Añadir la fase C mientras se mezcla.
 7. Enfriar el lote hasta 70°C.
