## Procédure:

1. Dans des récipients séparés, combiner les ingrédients des phases A et B. Chauffer jusqu'à 75-80°C.
2. Ajouter la phase A à la phase B tout en mélangeant. Homogénéiser 60-90 sec. Dans un récipient séparé, combiner les ingrédients de la phase C. Mélanger jusqu'à homogénéité.
3. Refroidir le lot à 50°C tout en mélangeant. Ajouter les ingrédients de la phase C tout en mélangeant. Homogénéiser avec 2500-3500 RPM, 90 sec.
4. Refroidir le lot à 30°C tout en mélangeant.
5. Ajouter les phases D et F en mélangeant. Homogénéiser avec 2500-3500 RPM, 90 sec.
