Procedimiento:

1. Combine los ingredientes de la fase A. Agregue los ingredientes de la fase A al agua tibia (50-55°C). Mezclar hasta obtener una solución homogénea. Enfriar el lote hasta por lo menos 50°C.

2. Añadir los ingredientes de la fase B mientras se mezcla. Mezclar hasta que quede uniforme. Enfríe el lote a por lo menos 30°C.
3. Agregue cocoamidopropil betaína durante la mezcla. Mezclar hasta que quede uniforme.
