2. Tambah Xanthan Gum ke Gliserin - gaul sehingga seragam. Masukkan fasa B ke fasa A semasa mengadun. Gaul sehingga seragam.
3. Sejukkan kumpulan ke sekurang-kurangnya 50°C.
4. Satukan bahan dari fasa D dalam bekas yang berasingan dan gaul sehingga sekata.
5. Masukkan bahan dari fasa C, D dan E ke fasa A sambil digaul. Gaul sehingga seragam.
