Procedure:

1. Combineer ingrediënten uit fase A. Voeg langzaam Acrylates/C10-30 Alkyl Acrylate Crosspolymer toe aan water terwijl je mengt. Meng tot uniform. Voeg andere fase A-componenten toe. Homogeniseren met 2000-3000 RPM, 90-120 sec.
2. Voeg tijdens het mengen natriumhydroxide (20% oplossing) toe. Meng tot uniform.
3. Voeg tijdens het mixen fase C-ingrediënten toe. Homogeniseren met 2000-3000 RPM, 120-180 sec.
