 2. 그다음 ROKAMmin K15K를 넣고 섞으세요.
 3. ABS산 혼합물을 첨가하십시오.
 4. EXOsft PO30을 첨가하고 혼합하면 균일한 용액이 얻어집니다.
 5. ROKAnol LP400을 넣고 섞으세요.
6. 글리세린, GLDA, 염화나트륨 혼합물을 첨가하십시오.
 7. 혼합물의 pH가 7.0~9.0 정도가 되도록 수산화나트륨을 첨가합니다.
 8. 마지막으로 페녹시에탄올, 향료 및 효소를 넣고 투명한 액체가 될 때까지 섞으십시오.
