Procedura:

1. Unire gli ingredienti della fase A. Aggiungere lentamente Acrylates/C10-30 Alkyl Acrylate Crosspolymer all'acqua durante la miscelazione. Mescolare fino ad ottenere un composto uniforme. Aggiung altri componenti della fase A. Omogeneizzare con 2000-3000 giri/min, 90-120 sec.

2. Aggiungere idrossido di sodio (soluzione al 20%) durante la miscelazione. Mescolare fino ad ottenere un composto uniforme.

3. Aggiungere gli ingredienti della fase C continuando a mescolare. Omogeneizzare con 2000-3000 RPM, 120-180 sec.
