prosedür:

1. A fazındaki malzemeleri ılık suya (40-50°C) ekleyin. Üniforma kadar karıştırın.
2. Ardından, bir koruyucu eklemeden önce karışımı oda sıcaklığına soğutun ve kalan malzemeleri ekleyin.
3. pH aralığını kontrol edin – gerekirse Sitrik Asit ekleyin. Ayarlamadan sonra iyice karıştırın.
