Procédure:

1. Ajouter les ingrédients de la phase A dans de l’eau tiède (40-45°C). Remuer jusqu’à l’obtention d’une solution homogène.

2. Refroidir le lot à au moins 35°C.

3. Ajouter les ingrédients de la phase B tout en mélangeant. Remuer jusqu’à l’obtention d’une solution homogène.
4. En remuant constamment, ajouter les ingrédients de la phase CE. Mélanger jusqu’à l’obtention d’une consistance homogène.

5. Ajuster le pH avec de l’acide lactique à un niveau de 5,0 à 5,5.
