## Postup:

1. V oddělených nádobách smíchejte přísady z fáze A a B. Fáze A homogenizujte: 1500-2000 ot./min. 90-120 s.
2. Fáze A a B se zahřejí na 75-80 °C.
3. Přidejte fázi B k A za míchání. Homogenizace: 1500-2000 RPM 90-120 s.
4. Vsázka se za míchání ochladí na 30 °C.
5. Během míchání přidejte složku fáze C. Homogenizace: 1500-2000 RPM 90-120 s.
