Procédure:

1. Dans un récipient principal, combiner les ingrédients de la phase A. Chauffer la phase A à 75-80°C tout en mélangeant.
 2. Dans un récipient séparé, je combine les ingrédients de la phase B.
 3. Chauffer la phase B à 75-80°C.
4. Ajouter B dans A, bien mélanger, maintenir A/B à 75-80°C. Homogénéiser avec 2000-3000 RPM, 90 sec.
 5. Refroidir le lot à 30°C tout en mélangeant.
 6. Ajouter EXOsoft PC35, EXOsoft PO30 – mélanger jusqu'à homogénéité.
