## 절차:

- A 단계의 재료를 섞습니다. A 단계의 재료를 따뜻한 물 (45-50°C)에 넣습니다. 균일한 용액이 얻어질 때까지 혼합합니다.
- 2. 혼합하는 동안 Disodium Laureth Sulfosuccinate 첨 가합니다. 균일해질 때까지 섞는다.
- 3. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate를 추가합니다. 균일해질 때까지 섞는다. 배치를 30℃ 이 상으로 식힙니다.
- 4. 혼합하는 동안 Cocamidopropyl Betaine 첨가하십 시오. 균일해질 때까지 섞는다.
- 5. 젖산을 추가하여 최종 pH를 5.0 6.5로 재조정합니다.
