

Procedure:

1. Combine ingredients from phase A. Add ingredients from phase A to water and heat to 50°C. Mix until homogenous solution is obtained.

2. Cool the batch down to at least 30°C.

3. Add slowly Coco Betaine and Parfum while mixing. Mix until uniform.
