1. A 단계의 성분을 합칩니다. 혼합하면서 아크릴레이트/C10-30 알킬 아크릴레이트 크로스폴리머를 물에 천천히 추가합니다. 균일해질 때까지 혼합합니다. 다른 A단계 구성요소를 추가합니다. 2000-3000RPM, 90-120초로 균질화합니다.
2. 혼합하는 동안 수산화나트륨(20% 용액)을 추가합니다. 균일해질 때까지 혼합합니다.
3. 혼합하는 동안 상 C 성분을 추가합니다. 2000-3000RPM, 120-180초로 균질화합니다.
