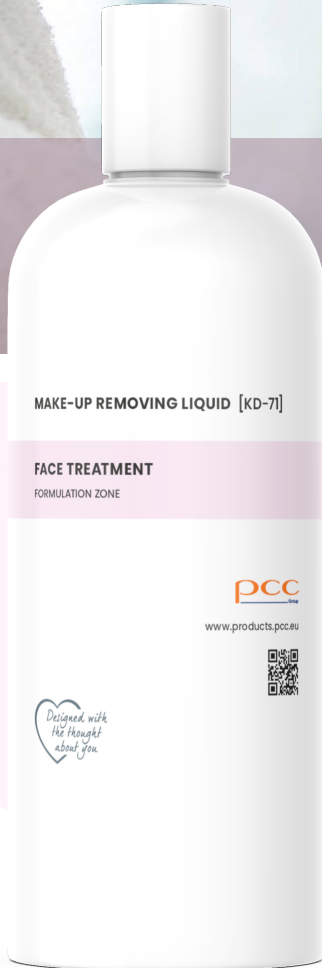

prosedür:

1. Bir ana kapta A fazındaki malzemeleri birleştirin ve 65–70°C’ye kadar ısıtın.
2. Gliserin’e Xanthan Gum ekleyin – homojen olana kadar karıştırın. Karıştırırken faz B’yi faz A’ya ekleyin. Üniforma kadar karıştırın.
3. Partiyi en az 50°C’ye soğutun.
4. D fazındaki malzemeleri ayrı bir kapta birleştirin ve homojen olana kadar karıştırın.
5. Karıştırırken faz C, D ve E’deki malzemeleri faz A’ya ekleyin. Üniforma kadar karıştırın.
