## Procedure:

- Mix buffer (Sodium bicarbonate and Sodium carbonate) with water until dissolved.
- Add 2-Butoxyethanol and ethanol and mix.
- Add SULFOROKAnol L227/1 and mix.
- Then add ROKAnol NL3 and ROKAnol NL6 and mix.
- Add ABSNa 25 and mix.
- Then add EXOtrope SCS and mix.
- Add Nonionic carnauba emulsion and mix.
- If necessary, adjust the pH to around 7.0
- Finally, add Methylisothiazolinone, Metylochloroizotiazolinon and parfum and mix until.
